The Ad Hoc Producer Reassignment Committee is established to identify, evaluate, and recommend policies and procedures for Governing Committee consideration to mitigate the disruptive impacts of commercial ERP reassignments needed to realign ceded books of business to maintain equity among Servicing Carriers. Prior committee discussions have included the following topics:

- Tolerance for variance of the ceded book volume among Servicing Carriers
- Alternative expense allowance allocation methods
- Modified producer assignment procedures
 - o affiliated agency groups
 - o assignments by territory
 - o reassignments for new business only
- Assigned risk versus assigned producer distribution approach

The Committee should be prepared to begin discussions of its charge by commenting on those topics listed above for further evaluation and identifying additional topics for consideration.
