24.01 Records of Previous Meeting

The Governing Committee unanimously voted to approve the records of the 2024 Annual Meeting held on November 19, 2024. The records have been distributed and are on file.

25.04 2025 Annual Report

Rules 4.D. and 24.D. of CAR's Rules of Operation require an Annual Meeting of the Governing Committee in conjunction with the Annual Meeting of the Members of CAR, at which time a summary of the previous year's activities shall be reported. Accordingly, Ms. Natalie Hubley briefly reviewed the Fiscal Year 2025 Annual Report as prepared by CAR staff. After brief discussion, the Governing Committee unanimously voted to authorize distribution of the 2025 Annual Report to CAR's Members, the Commissioner of Insurance, and the producer members on CAR's committees.

25.05 Election of Chair and Vice Chair

Rules 4.C.1. and 24.C.1. of CAR's Rules of Operation provide that the Governing Committee, at its Annual Meeting, shall select a Chair and Vice Chair of the Committee. Chair William Hughes turned the meeting over to CAR's President, Ms. Hubley, to preside over the election.

Ms. Hubley noted that CAR Rules provide that the Committee may elect the incumbent Chair and/or Vice Chair to a second one-year term.

On a motion made by Ms. Sarah Clemens and seconded by Ms. Meredith Woodcock, the Committee unanimously voted, with Mr. Hughes recused, to elect Mr. William Hughes for the position of Governing Committee Chair.

On a motion made by Mr. Thomas DePaulo and seconded by Ms. Meredith Woodcock, the Committee unanimously voted, with Mr. Olivieri recused, to elect Mr. John Olivieri, Jr. for the position of Governing Committee Vice Chair.

Ms. Hubley turned the meeting over to the newly elected Chair.

There being no other business to come before the 2025 Annual Meeting, a motion to adjourn passed unanimously.
