### 23.01 Records of Previous Meeting

The Committee voted unanimously to approve the Records of the Budget Committee meeting of September 7, 2023. The Records have been distributed and are on file.

#### 24.04 Fiscal Year 2025 Budget and Business Plan

Ms. Natalie Hubley reviewed highlights of CAR's proposed fiscal year 2025 business plan which describes the organization's operational objectives. She advised that the objectives are targeted toward enhancements in support of the private passenger residual market, continued momentum to improve commercial results, as well as the improved efficiency in the delivery of services to CAR's various business partners.

Mr. Steven Gautieri advised that CAR management is requesting a FY25 budget allocation of \$9,924,000, which represents a decrease of 1.4%, or \$140,200, below FY24. He further noted that staff expects to close FY24 \$32,600 under budget and that the proposal recommends the surplus be allocated to fund CAR pension expenses, consistent with the strategy adopted in 2013.

Mr. Gautieri presented a detailed review of the proposed FY25 budget, providing explanations and rationale of variances between FY24 and FY25. He advised the committee that the budget reduction results

from the renegotiated office lease terms effective September 1, 2024. Further, staff advised that this budget supports management's gradual implementation of strategic succession planning objectives.

After discussion, the Committee unanimously voted to recommend to the Governing Committee approval of the FY25 administrative expense budget and business plan as proposed.
