24.17 Ad Hoc Office Lease Review Committee

Mr. Olivieri:	The first agenda item is the report of the Ad Hoc Office Lease Review Committee. I am going to defer to staff to give us an overview of what that committee did. But before that, just from a background standpoint, CAR's lease is coming up in the near future. Natalie has been keeping Bill Hughes, the Vice Chair, and myself apprised of the situation and their conversations. What we proposed, or I did, was we put an ad hoc committee together with some folks who have real estate backgrounds in the Boston area to vet the offer we received to extend our lease from the new building owner. That committee – and I'll let Nat and Steve get into the details – but that committee unanimously, based on a couple of contingencies which did come through, recommended that we extend our lease for the terms that staff will get into. So, at this point, I will turn it over to Natalie and you can explain where we are.
Ms. Hubley:	John, before we do that, I think, because this committee is going to be discussing negotiations for our lease term and the potential for further discussion on that
Mr. Olivieri:	Executive session.
Ms. Hubley:	Exactly.
Mr. Olivieri:	Yes. So, having said that, I gave you the background and now to get into the details, I would entertain a motion for us to go into executive session to talk about lease negotiations.
Mr. Hincks:	If I might jump in. I think you might want to state for the record, if it is the case, that you have a concern that a discussion of this topic in an open and public meeting may or could be detrimental to CAR's bargaining position in relation to the landlord, and that's the reason for the committee to considering going into executive session.
Mr. Olivieri:	As Ben just said, I am going to concur that that is why we're going into executive session. That was by design, Ben. I knew you'd jump in and take care of doing all the talking. In any case, I will now entertain that motion to go into executive session.
