## 17.06 Point Insurance Agency, Inc./Arbella Protection Insurance Company

A Request for Review was submitted by the Point Insurance Agency, Inc. requesting relief of the termination of the agency's commercial automobile Exclusive Representative Producer appointment by the Arbella Protection Insurance Company for violations of CAR Rule 14.B.1. c., e., k., l., and n., Ongoing Exclusive Representative Producer Requirements, and the agency's Limited Servicing Carrier Agreement with Arbella. The agency's Request for Review, Arbella's Notice of Termination, as well as other pertinent documentation were previously provided to the Market Review Committee for its meeting of September 12, 2017. Refer to assigned Docket #MR17.06, Exhibits #1 through #4.

At the September 12, 2017 meeting of the Market Review Committee, Point Insurance Agency, Inc. requested a continuance of the proceedings. Following discussion relative to the late withdrawal of counsel for the agency, the Market Review Committee voted to allow a continuance of the matter.
