18.12 Radius of Operation and Rating Territory

The Subcommittee will continue its discussion relative to options for proposed modifications to Rule 72 – Public Automobile Classifications of the Commercial Automobile Insurance Manual to enhance consistency in the determination of the Radius of Operation and Rating Territory.

Subcommittee members agreed to consider methodology to determine rating territory in instances where the public vehicle travels through several territories on its way to the terminus point. Members should provide staff with input to prior to the meeting and be prepared to further discuss this issue at the meeting.

18.14 Requirements for Vehicle Operations in Massachusetts

In order to strengthen the eligibility requirements for placement in the residual market, the Subcommittee should consider whether requirements for vehicle operations in MA can be incorporated. A summary of how risks with multi-state operations are addressed in other states' plans will be distributed as additional information prior to the meeting.
